



Call for applications of Postdoctoral Fellows – DDEA Postdoc Summit 2025

Created in April 2012 by the Fonds de Recherche du Québec – Secteur Santé (FRQ), the **Research Network on Cardiometabolic Health, Diabetes and Obesity (CMDO)** aims to pursue the development of research into metabolic and cardiovascular health, diabetes and obesity, and to transfer and mobilize knowledge to promote sustainable health among Quebecers.

The network is calling to take part in the Danish Diabetes Academy (DDEA) Postdoc Summit, which will take place from 6 to 9 October 2025 in Kibæk, Denmark (Sinatur Skarrildhus Hotel/Conference, site web à venir). Postdoctoral fellows from all teams of regular members of the network are invited to participate in this competition. Selected participants will have to make an oral or poster presentation (determined by the congress organization). The aim of the congress is to guarantee a high-quality scientific program and facilitate interactions especially between speakers (internationally renowned researchers) and young researchers. The DDEA will cover local costs (conference registration, meals and accommodation (personal expenses and extended accommodation are not included)) of Quebec participants selected by the CMDO Network. For its part, the CMDO will pay \$750 per participant to reimburse part of the transportation costs. <u>All</u> other fees will be borne by the participant and / or its director.

Deadline for submitting applications is <u>April 21, 2025</u>.

Women, Aboriginal people, visible minorities, ethnic minorities, people with disabilities and people from the 2SLBGTQIA+ community are encouraged to apply. For evaluation purposes, we strive to recruit a diverse committee that reflects the profiles of the applicants and ensure an evaluation process that takes into account the particular situations of the applicants, including atypical trajectories.

The eligibility criteria and the evaluation method are described below. Requests submitted late, incomplete or that do not meet the eligibility criteria will not be evaluated. Selected candidates will be contacted no later than **May**.

Eligibility criteria:

- 1) To be a postdoctoral fellow, whose research director is a <u>regular member</u> of the CMDO Network. The research director must be a member of the network <u>before</u> applying to the competition.
- 2) T Have a research project related to diabetes, metabolism or endocrinology.
- 3) Excellence and involvement:
 - Have an excellent academic record.





- 4) Demonstrate a motivation to pursue a research career in one of the network's areas of focus: Cardiometabolic Health, Diabetes and Obesity.
- 5) Speak and understand English (conferences and discussions are in English).
- 6) Selected participants will be required to submit a scientific abstract to this event which will take place on October 6-9, 2025 in Kibæk, Denmark (deadline for submission: **June 2025**).
- 7) Please note that a postdoctoral fellow may be a winner for this competition only once. As a result, previous winners cannot participate in this contest. However, nothing prevents them from attending the congress at their expense.

Application evaluation process:

The executive committee of the network will evaluate all applications submitted. The results of the competition will be announced no later than **in May**.
